**TERMS OF PARTICIPATION**

- Your intention to attend the Symposium should be notified to us before **May 30, 2010** (by registering on-line at <http://www.ibna.ro/en/simpozion/simpozion.php> or by e-mail at [symposium@ibna.ro](mailto:symposium@ibna.ro)). The full papers should be submitted to [symposium@ibna.ro](mailto:symposium@ibna.ro) before **June 30, 2010**.
- Upon your registration, we will assign you a contact person, who will be in touch with you until symposium date / publication of your article.
- The scientific contributions, presenting original data of the authors, can be presented as theatre presentation or as poster. The duration of a theatre presentation will not exceed 10 minutes.
- For the scientific contributions presenting syntheses / reviews (**invited lecturers**) 20-25 de minutes will be assigned.
- Presenters are recommended to prepare a computer presentation for on-screen display, in **Microsoft PowerPoint 2003** format. Please try to send the PowerPoint presentation by email before September 20, so that we can check it and load it onto our computer before the symposium date. You will be able to preview your presentation before the sessions begin.
- Posters are to be displayed on **85 x 110 cm panels**. Upon recommendation from the Program Committee, some posters can also be presented in more detail during the poster session.
- An author can contribute to the Symposium with no more than two papers as single or first author.
- The Organizing Committee will notify the contributors whether their papers have been accepted or not for presentation in the Symposium. All papers accepted for presentation (theatre presentation or poster) will be published in abstracts in the **Book of Abstracts**.
- Submitted articles will be also peer-reviewed for publication in “**Archiva Zootechnica**” or “**Analele IBNA**”.
- The registration fee is **100 Euro**. You can either pay **by transfer into institute’s account** RO98RNCB0091005021600016, opened at Banca Comerciala Româna, Agentia OTOPENI, or you can pay **cash on the opening day** of the Symposium (**invoices and receipts will be provided**).

## INSTRUCTIONS TO AUTHORS

Papers should be prepared with a minimum of formatting, in a single column layout. As our staff will re-format all papers into a standard layout, we only require unformatted text from contributors, without the use of special effects or layout features such as headers and footers. However, you can use simple effects such as bold, italics, superscript and subscript. Please make sure that the tables and pictures/charts will fit to a maximum printed page width of 12.5 cm. Resizing them during re-formatting might cause distortions and errors.

All contributions must be written in English. We recommend that the English of your paper is reviewed by a professional translator or native English speaker.

**Line spacing:** 1 line throughout the document, no page numbers.

**The title** should be as brief as possible, but it should include, nevertheless, sufficient information on the subject of the paper and on the species involved when applicable.

**Authors' names** [given name, last (family) name]. If there is more than one author, the affiliations will be footnoted using figures, 1; 2; 3 etc, written in superscript and be placed below the author names. The corresponding author should be indicated with an asterisk and followed by an e-mail address. Do not give authors' titles, positions, or degrees.

**The abstract:** no more than 2,500 keystrokes (characters plus spaces) in one paragraph.. The abstract should summarize pertinent results in a brief but understandable form, should start with a clear statement of the objective and must conclude with one or two sentences that highlight important conclusions. References are never cited in the abstract.

**Keywords.** After the abstract list up to 5 key words.

**Headings** are: "Introduction", "Materials and methods", "Results and discussion", "Conclusions", "Acknowledgments" (optional) and "References".

### Introduction

The introduction must not exceed 2,500 keystrokes (characters plus spaces). It briefly justifies the research (argues the opportunity of the research) and specifies the hypotheses to be tested. Extensive discussion of relevant literature should be included in the discussion of results, not in the introduction. To limit the length of the introduction and to avoid repeating, generally no more than three references should be cited to support a specific concept.

## **Materials and Methods**

A clear description or specific original reference is required for all biological, analytical, and statistical procedures. All modifications of the original procedures must be explained. Diets, animals (breed, sex, age, body weight), data recording conditions, surgical techniques, measurements, and statistical models should be described clearly and fully.

## **Results and discussion**

Results (which may be presented separately or combined in one section with the Discussion) should be presented in tabular form when feasible. If data are discussed in the text but are not included in tables or figures, specify “(data not shown)” in the text. The text should explain or elaborate on the tabular data, but numbers should not be repeated extensively within the text (even if presented in a different form). The values must be accompanied by information on the volume of the primary data, all with some index of variation attached, to allow the reader to interpret correctly the results of the experiment. The discussion (which may be presented separately or combined with Results) should interpret the results in terms of biological mechanisms and should integrate literature results with the research findings. Avoid presenting results and references to tables and figures already described in the Results section. The possible differences from other authors or data inconsistencies must be mentioned and explained.

## **Conclusions**

You should underline, in few phrases, the most important findings of the article, the ones that are supported by your results. Please avoid general statements, on well-known facts. If applicable, try to highlight practical implications.

## **References**

The authors are encouraged to use references as recent as possible, from ISI-quoted journals or indexed in international databases. The references should be ordered alphabetically. Do not number the references.

- for articles: [name], [first name initial], [year] - [title], [subtitle], [name of the journal], [volume number], [issue number], [range of pages]

- for books: [name], [first name initial], [year] – [title], [subtitle], [edition number], [publishing house], [place of issue], [range of pages of the referred paper]

## **Tables**

Number the tables in the order of appearance in the text. Table row width should not exceed 12.5 cm. The abbreviations must be spelled out in numbered footnotes placed below the table, so the tables should be self-explanatory. For differences among means within a row or column, superscript letters should be used as appropriate sequentially (e.g., a, ab, b, c, cd) consistently from largest to smallest means.

### **Figures, charts, B-W pictures**

Number them in the order of appearance in the text. Captions should be typed below the figure/chart/picture. Figures/charts/pictures width should not exceed 12.5 cm.

### **For articles on commercial products**

Articles describing studies on commercial products are accepted for communication / publication, with the following rules:

- no trademark in the title, but identification of the nature of product, active substance, vegetal species (case of plant extracts), source, etc.
- no trademark in the tables with results
- introduction of the trademark is to be done in Materials and Methods, together with the company name & address
- the company name may also appears with the affiliation of the authors (e.g. if they work for the company), as for any other institution
